Whereas, the IGP, Jammu Zone, Jammu being the Authorized Officer under sub rule (1) of Rule 3 of Temporary Suspension of Telecommunication Service Rules, 2024, has issued directions to the Telecom Service Providers (TSPs)/Internet Service Providers (ISPs) to suspend mobile data services temporarily (3G/4G/5G and public wifi) and reduce 2G data services to less than 100 KBPS speed in Doda and Bhaderwah Towns of District Doda of Jammu Province w.e.f 24.04.2025 (2315 hours) to 25.04.2025 (2000 hours) and;

Whereas, the order/letter under reference, inter-alia, mentions that Mobile Data (2G/3G/4G/5G and public wifi) services are likely to be misused by anti-national elements/miscreants, which may cause deterioration in public order and unrest among the general masses.

Now, therefore, upon consideration of the various aspects, as brought out in the material provided by the Authorized Officer, I, Principal Secretary to Government, Home Department, being satisfied that there was absolute necessity for issuance of the aforesaid directions by the Authorized Officer, without obtaining prior approval of the Competent Authority, in the interest of sovereignty and integrity of India, the security of the State/UT and for maintaining public order, hereby confirm Order No. 559(TSTS) of 2025 dated 25.04.2025, under endorsement No. JZ/CS/Snap-down/2025/560-61 dated 25.04.2025 issued by the Authorized Officer, in exercise of powers conferred under sub-Rule (1) of Rule 3 of the Temporary Suspension of Telecommunication Service Rules, 2024 read with clause(b) of sub section (2) of section 20 of the Telecommunication Act, 2023.
