Whereas, the IGP, Kashmir Zone, Srinagar being the Authorized Officer under sub rule (1) of Rule 3 of Temporary Suspension of Telecommunication Service Rules, 2024, has issued directions to the Telecom Service Providers (TSPs)/Internet Service Providers (ISPs) to shut down mobile towers temporarily having following Cell IDs: 405-55-561-231637259, 405-55-561-231637260 and 405-55-561-231637261 located in the Bradipathri, Charar-e-Sharief area of District Budgam w.e.f 17.05.2025 (2100 hours) to 19.05.2025 (2200 hours) and;

Whereas, the order/letter under reference, inter-alia, mentions that Mobile tower/data services are likely to be misused by anti-national elements/miscreants, which may compromise security deployment and deterioration in public order.

Now, therefore, upon consideration of the various aspects, as brought out in the material provided by the Authorized Officer, I, Principal Sceretary to Government, Home Department, being satisfied that there was absolute necessity for issuance of the aforesaid directions by the Authorized Officer, without obtaining prior approval of the Competent Authority, in the interest of sovereignty and integrity of India, the security of the State/UT and for maintaining public order, hereby confirm Order No. 1559(TSTS) of 2025 dated 17.05.2025, under endorsement No. KZ/CS/Snap-down/2025 dated 17.05.2025 issued by the Authorized Officer, in exercise of powers conferred under sub-Rule (1) of Rule 3 of the Temporary Suspension of Telecommunication Service Rules, 2024 read with clause(b) of sub section (2) of section 20 of the Telecommunication Act, 2023.
