**Government Order No: Home – 17(TSTS) of 2025**


**Dated: 10.09.2025**

Whereas, the IGP, Jammu Zone, Jammu being the Authorized Officer under sub rule (1) of Rule 3 of Temporary Suspension of Telecommunication Service Rules, 2024, has issued directions to the Telecom Service Providers (TSPs)/Internet Service Providers (ISPs) to suspend mobile data services temporarily (2G/3G/4G/5G/public & private wifi including Fibre/Broadband) in District Doda of Jammu Province w.e.f 10.09.2025 (0001 hours) to 10.09.2025 (2359 hours) and;

Whereas, the order/letter under reference, inter-alia, mentions that Mobile Data (2G/3G/4G/5G/ public & Private wifi including Fibre/Broadband) services are likely to be misused by anti-national elements/miscreants, which may cause deterioration in public order.

Now, therefore, upon consideration of the various aspects, as brought out in the material provided by the Authorized Officer, I, Principal Secretary to Government, Home Department, being satisfied that there was an absolute necessity for issuance of the aforesaid directions by the Authorized Officer, without obtaining prior approval of the Competent Authority, in the interest of maintaining public order and for preventing incitement to the commission of any offence, hereby confirm Order No. 1252(TSTS) of 2025 dated 10.09.2025, under endorsement No. JZ/CS/Snap-down/2025/1253-54 dated 10.09.2025 issued by the Authorized Officer, in exercise of powers conferred under sub-Rule (1) of Rule 3 of the Temporary Suspension of Telecommunication Service Rules, 2024 read with clause(b) of sub section (2) of section 20 of the Telecommunication Act, 2023.


